2. Located on the Subject Property is a two-story, single family frame residence.


### WHEREFORE, IT IS HEREBY ORDERED that:

- A. Judgment is entered in favor of plaintiff City of Chicago and against Defendants Wells Fargo Bank, N.A., Celestine McGowan, Sharon Burnham, Faranse Burnham, Darin Burnham, Beverly Thompson, Timothy McGowan, and Gregory McGowan.
- B. A permanent injunction is entered not to rent, lease, use, occupy, convey, or transfer, or sell the Subject Property.
- C. The City of Chicago is authorized to keep the subject property boarded and secured until such time it is demolished.
- D. The City of Chicago has authority to demolish the subject property, effective immediately.
- E. Defendants Wells Fargo Bank, N.A., Celestine McGowan, Sharon Burnham, Terrance Burnham, Darin Burnham, Beverly Thompson, Timothy McGowan, and

Gregory McGowan are ordered to pay board up costs in the amount of \$ 6,058.30

- F. Pursuant to 65 ILCS 5/11-31-1 and the City's police powers under Article VII of the Illinois Constitution, and Section 13-12-130 of the Municipal Code of Chicago, the City is authorized to immediately demolish the building situated on the Subject Property and is entitled to a lien for the costs of demolition, court costs and other costs enumerated by statute.
- E. The City's performance under this order will result in a statutory in rem lien that attaches only to the subject parcel of real estate. If the City seeks a personal judgment against any individual party to this action, it will proceed by separate motion directed to that party.
- F. Pursuant to Line's Supreme Court Rule 304(a), this is a final and appealable order and personal judgment, the Court finding no just reason to delay the enforcement or appeal of this final order and judgment.
- G. The Court reserves jurisdiction of this cause to enforce the terms of this Order, for the purpose of ascertaining denolition costs for entry of money judgments against the defendant owners, and for the purpose of hearing foreclosure proceedings, as defined by the applicable statutes and ordinances.
