#### <u>DECLARATION</u> OF TRUST

I, JEAN D. STOCKE, of Glenview, Illinois, have transferred to myself as Trustee the property listed in the attached schedule. This declaration of trust and the trusts hereby evidenced shall be known as "THE JEAN D. STOCKE DECLARATION OF TRUST DATED JULY 28, 2010". I declare that I hold that property and all investments and reinvestments thereof and additions thereto (referred to below as the "Trust Estate" and components of the Trust Estate are referred to below as "Trust Property") upon the following trusts:

#### ARTICLE I - ADMINISTRATION DURING MY LIFETIME

During my lifetime the Trustee shall pay so much or all of the income and principal of the Trust Estate to me or otherwise as I direct. If at any time or times I shall be unable to manage my affairs, the Trustee may use such sums from the income and principal of the Trust Estate as the Trustee deems necessary or advisable for my care, support and comfort, or for any other purpose the Trustee considers to be for my best interests. Any excess income shall be added to principal.

For purposes of this declaration, I shall be considered to be mable to manage my affairs if I am under a legal disability or by reason of illness or mental or physical disability am unable to give prompt and intelligent consideration to my financial matters. The determination as to my inability at any time shall be made by my then attending physician, or if none, a physician who has examined me and who is familiar with my medical history (referred to in either event as my "Physician"), and my son, CHRISTOPHER J. STOCKE ("CHRISTOPHER"). The determination shall be unanimous between my Physician and CHRISTOPHER. If, for any reason, CHRISTOPHER is then either unable or unwilling to participate with my Physician in making such determination, then the decision of my Physician, acting alone, shall be sufficient. All acting and nominated Trustees and all third parties may rely upon such determination, certified in writing, and signed by my Physician and, if

SECTION 8: I may resign 2.5 Trustee at any time by written notice to my son, CHRISTOPHER J. STOCKE, and my son, MICHAEL J. STOCKE. Upon my death or resignation, or my refusal or inability to manage my affairs, my son, CHRISTOPHER J. STOCKE, shall become successor Trustee. In case of the death or resignation, or the refusal or inability for any reason to act or to continue to act of my son, CHRISTOPHER J. STOCKE, then my son, MICHAEL J. STOCKE, shall become successor Trustee. In case of the death or resignation on the refusal or inability for any reason to act or to continue to act of both of the preceding as successor Trustee, I if living, otherwise the beneficiary or a majority in interest of the beneficiaries then entitled to receive or have the benefit of the income of the trust, shall appoint an individual as successor Trustee. The term "Trustee" shall mean the Trustee or Trustees (including Co-Trustees) from time to time qualified and a ring.

Any successor Trustee may resign at any time by written notice to me if I am then living, otherwise to each beneficiary then entitled to receive or have the benefit of the income from the trust. No resignation shall be effective until there is a successor Trustee who is ready, willing and able to act.
