claimant agreed to perform the requested extra work. As a result, the price of the construction contract was increased to \$27,000.00.

- 4. That all of the labor and materials furnished and delivered by the undersigned claimant were delivered and used to permanently and substantially improve the above-described real property.
- 5. That on or about June 14, 2012, the Owner wrongfully terminated the contract with the undersigned without allowing the undersigned to complete its work on the Owner's project.
- 6. That on or about June 14, 2012, the undersigned claimant, pursuant to the Owner's request, stopped its work on the Property.
- 7. That there is now justly due and owed to the undersigned claimant after allowing all credits, deductions, payments and offsets, the outstanding amount of **eighteen thousand dollars** (\$18,000.00), plus all her recordation costs, attorney fees and interest at the rate specified in the Illinois Mechanics Lien Act.
