This Subordination Agreement made as of the 20th day of July, 2012, by Gold Coast Bank, having an address of 1201 N Clark St, Ste 204, Chicago IL 60610 ("Subordinator"), and Gold Coast Bank, a corporation organized and existing under the laws of the State of Illinois with its principal place of business at 1201 N Clark St, Ste 204, Chicago IL 60610.

LOAN AMOUNT*

- A. Jamsheed Iqbal and Najwa Zafar, of Chicago, Cook, Illinois ("Borrower"), has applied to Lender for a loan amount of Four Hundred ~~Seventeen~~ Thousand and 00/100 Dollars (~~\$417,000.00~~) to be made to Borrower and to be evidenced by a promissory note secured by a mortgage covering certain real property located at 433 N Wells St#501, Chicago IL 60654.
- B. The real property offered by Borrower as security to Lender is currently subject to the prior lien of the mortgage described below.



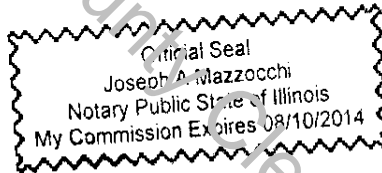
