NOW COMES, KAREN HANSEN, in the capacity of Independent Executor of the Estate of Joanne C. Hansen, Deceased, for her Petition for Approval of Disclaimer and in support thereof states as follows:

- 1. JOANNE C. HANSEN (the "Decedent"), died on March 10, 2012, a resident of Cook County, Illinois.
- 2. On June 27, 2012, the Decedent's Will dated April 25, 2000 (the "Will"), was admitted to probate by Order of this Court, and Letters of Office were issued to KAREN HANSEN ("Karen"), as Independent Executor of the Decedent's Estate.
- 3. The Decedent's son, DAVID E. HANSEN ("David"), predeceased the Decedent on January 25, 2012.
  - 4. At the time of his death, David was unmarried and did not have any descendants.
- 5. Upon information and belief, David died intestate. His estate is currently being administered by his brother, ROBERT C. HANSEN ("Bert") in the Probate Division of the Circuit Court of Cook County, case number 2012 P 1041.

- 6. David was survived by his father, ROBERT O. HANSEN ("Robert"), his brother, Bert, his brother, JONATHAN C. HANSEN ("Jonathan"), his sister, Karen, his sister, MARCIA OGDEN ("Marcia"), and his mother, the Decedent. None of David's siblings predeceased him.
- 6. At the time of his death, David owned a one-fifth (1/5) interest in real estate located at 2531 Glen Eagles Drive, Olympia Fields, Cook County, Illinois (the "Property").
- 7. Each of David's surviving siblings, namely, Bert, Jonathan, Karen, and Marcia (collectively, the "Siblings") a'so own an undivided one-fifth (1/5) interest in the Property.
- 8. David and his siblings received the Property from their parents pursuant to the terms of a qualified personal residence trust (the "QPKT") created by Robert as Grantor and the Decedent as Trustee on March 28, 2000.
- 9. In April 2001, Robert and the Decedent filed gift tax returns reporting the gift of the Property to the QPRT. By making the gift, Robert and the Decedent intended that the Property would pass automatically to David and his siblings at the termination of the QPRT and would not revert back to the Decedent or be included in the Decedent's taxable estate.
- Because David died intestate, the Illinois rules of decent and distribution govern the distribution of David's estate. Section 2-1 of the Probate Act provides in pertinent part as follows:
  - § 2—1. Rules of decent and distribution. The intestate real and personal estate of a resident decedent and the intestate real estate in this State of a nonresident decedent, after all just claims against his estate are fully paid, descends and shall be distributed as follows: \* \* \*
    - (d) If there is no surviving spouse or descendant but a parent, brother, sister or

descendant of a brother or sister of the decedent: the entire estate to the parents, brothers and sisters of the decedent in equal parts, allowing to the surviving parent if one is dead a double portion and to the descendants of a deceased brother or sister per stirpes the portion which the deceased brother or sister would have taken if living. 755 ILCS 5/2-1.

- Property descends to Robert, Joanne, Bert, Jonathan, Karen and Marcia in equal shares.
- 12. The Decedent's Vill provides that the entire residue of her estate passes to the trustee of the Joanne C. Hansen Declaration of Trust (the "Trust"), the current trustee of which is Karen.
- 13. The Trust directs the trustee to divide the remaining trust estate, after the payment of the Decedent's debts, expenses and taxes, into two separate trusts. The first trust (the "Family Trust") will be funded with the largest amount that will result in no federal estate tax being payable by reason of the Decedent's death, and the second trust (the "Marital Trust") will be funded with the balance of the trust estate.
- 14. Robert is the sole current beneficiary of the Family Trust and the Marital Trust. David's siblings are the remainder beneficiaries of both trusts.
- 15. In the absence of a disclaimer by the Decedent's estate, a portion of David's interest in the Property would be included in the Decedent's gross estate for federal estate tax purposes. A fractional interest in the Property would also be included in the Decedent's probate estate and would eventually be distributed to her Trust.
- 16. The inclusion of a portion of the Property in the Decedent's gross estate could cause either her estate or Robert's estate to unnecessarily incur additional federal or state estate tax.

- 17. The inclusion of a portion of the Property in the Decedent's estate will also cause the Decedent's estate and Trust to unnecessarily incur additional recording and administrative fees.
- Robert and the Decedent's siblings have expressed a desire to have David's entire interest in the Property by-pass the David's estate, so that the Property will descend pursuant to Section 2-1 of the Probate Act directly to David's siblings, rather than to the Trust.
- 19. Robert has already disclaimed the interest in the Property that would have descended to him upon David's death. As a result of his disclaimer (and assuming that the Decedent's disclaimer is also approved by the Court), Robert will be treated as having predeceased David, and his interest in the property would pass entirely to Bert, Jonathan Karen and Marcia.
- 20. Section 2-7(a) of the Probate Act provides that the representative of a decedent may disclaim on behalf of the decedent with leave of court; and further provides that the court may approve the disclaimer by a representative of a decedent if it finds that the disclaimer benefits the estate as a whole and those interested in the estate generally even if the disclaimer alters the distribution of the property, part, or interest disclaimed. 755 ILCS 5/2-7(a).
- 21. Neither the Will nor any other instrument signed by the Decedent authorizes the representative of the Estate to disclaim without court approval.
- 22. Although a disclaimer executed by Karen in her capacity as Independent Executor would alter the distribution of David's interest in the Property under the Probate Act, it would benefit the estate as a whole and the beneficiaries of the Decedent's estate in the following respects: (a) the proposed disclaimer would conform with the Decedent's intention to gift the Property to her children, as reflected in the transfer to the QPRT in 2000, and the subsequent transfer to the Decedent's children in 2010; (b)

the disclaimed interest will pass directly from David's estate to his siblings rather than being included in the Decedent's taxable estate, thereby saving estate taxes; (b) the disclaimed interest will not have to be subject to probate proceedings in the Decedent's estate, thereby potentially saving fees and administrative expenses.
