17. Transfer of the Property or a Beneficial Interest In Borrower/Refinance of First Mortgage Loan. If all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) or the first mortgage loan obtained by Borrower from Lender in connection with the Property is refinanced by Borrower, in either event, without Lender's prior written consent, Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument.
