RELEASE OF ASSIGNMENT OF RENTS

INTEGRA BANK N.A. was the holder of a loan secured by the Assignment of Rents described below. On July 29, 2011, the Office of the Controller of the Currency closed Integra Bank and appointed the Federal Deposit Insurance Corporation (FDIC) as receiver. 
