
SUBORDINATION AGREEMENT





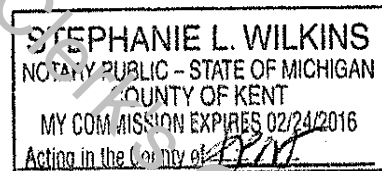
