- 1. A Final Judgment Order was entered on August 22, 2012, finding that the sum of \$132,500.00, in total, was the final just compensation to be raid to the owner and interested parties fee simple title to real property designated as Parcel No. 2/120002, which is attached hereto as Exhibit A to the Final Judgment Order and incorporated by reference, together with a temporary easement for construction purposes for a period not to exceed five (5) years from the date of vesting of title or until completion of construction operations, whicheve roccurs first, across and upon real property designated as Parcel No. 0H20002TE which is attached hereto as Exhibit B to the Final Judgment Order and incorporated by reference. 

NOW, THEREFORE, THIS COURT FINDS THAT:

1. The owner and interested parties in Parcel Nos. 0H20002, which is legally described in <a href="Exhibit A">Exhibit A</a> which is attached hereto and incorporated by reference, and 0H20002TE which is legally described in <a href="Exhibit B">Exhibit B</a>, which is attached hereto and incorporated by reference; are:

### SPIRIT OF AMERICA (STREAMWOOD) INC.

Said par y is entitled to receive for the taking of fee simple title to Parcel No. 0H20002 the sum of \$30,000.00 for the take; \$57,500.00 for damages to the remainder; and \$45,000.00 for the taking of a temporary construction easement for a period of time not to exceed five years or complaint of construction, whichever is sooner, to Parcel No. 0H20002TE; or \$132,500.00 in total.

- 2. Just compensation to the owner and interested parties for taking of fee simple title to Parcel No. 0H20002 the sum of \$30,000.00; \$57,500.00 for damages to the remainder; and \$45,000.00 for the taking of a temporary construction easement for a period of time not to exceed five years or completion of construction, which were is sooner, to Parcel No. 0H20002TE; or \$132,500.00 in total, and judgment is hereby entered in that amount. The agreed amount includes any claims for interest due from the Plaintiff to the Defendants.
- 3. That a motion was heretofore made by the Flaintiff for the immediate vesting to title to Parcel Nos. 0H20002 and 0H20002TE in the Plaintiff, and on the day of March 4, 2011, the court found the amount of preliminary just compensation to be \$96,200.00 in total; that the Plaintiff on April 7, 2011, deposited with the County Treasurer the preliminary just compensation; that on April 19, 2011, the Court ordered that the Plaintiff be vested with fee simple title to real property designated as Parcel 0H20002; together with a temporary easement for construction purposes for a period not to exceed five (5) years from the date of vesting of title or until completion of construction operations, whichever occurs first, across and upon real property designated as Parcel 0H20002TE, and did authorize the Plaintiff to take possession thereof.

IT IS ORDERED, ADJUDGED AND DECREED the payment of \$132,500.00 for the benefit of the owner or interested parties is full and final just compensation including all claims for interest due the Defendants from Plaintiff.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the order entered April 19, 2011, vesting the Plaintiff with fee simple title to Parcel No. 0H20002, together with a


