ORDER OF REVIVAL OF JUDGMENT


THIS MATTER coming on to be heard on the Petition of Plaintiff to revive a judgment entered on April 5, 2005 against Defendants ORBIT CONSULTING GROUP and STEVEN T. RACZ, individually, the Court does find, based upon the allegations of the petition, the representations of the Plaintiff and evidence taken, that:

1. A Judgment was entered in this Court on April 5, 2005 against Defendants ORBIT CONSULTING GROUP and STEVEN T. RACZ, individually, in the amount of \$257,203.78.
2. To date, no principal payments have been made against the Judgment.
3. The unpaid amount of the Judgment at this date is \$257,203.78.
4. Additionally, as of 1-5 2012, the sum of \$156,251.30 in statutory interest has accrued on the unpaid balance.
5. The Defendants have been given due notice by Personal Service.
6. The Plaintiff has not received notice of any discharge in bankruptcy of the Defendants, and in fact, on October 14, 2005, Defendant STEVEN T. RACZ, individually did file a Chapter 7 Bankruptcy Petition, but on July 31, 2007, Defendant STEVEN T. RACZ, individually, voluntarily waived his right to receive a discharge of debts in the Bankruptcy.

WHEREFORE, IT IS HEREBY ORDERED that the Judgment entered on April 5, 2005 in favor of Plaintiff CADLEWAY PROPERTIES, INC. and against Defendants ORBIT CONSULTING GROUP and STEVEN T. RACZ, individually, be and is hereby REVIVED in the amount of \$257,203.78.
