#### MEMORANDUM OF RIGHT OF REPURCHASE

In the event of any conflict between the provisions of the Agreement and those of this Memorandum, the provisions of the Agreement shall control.
- D. This Memorandum may be executed in one or more separate counterparts each of which, when so executed, shall be deemed to be an original. Such counterparts shall to gether constitute and be one and the same instrument.
