more commonly described as 7887 Lincoln Avanue, Skokie, Illinois (the "Subject Property"), petitioned the Village of Skokie for the repeat of Village Ordinance 93-1-Z-2341, which granted a special use permit, to allow a second itoo apartment over a liquor establishment at the Subject Property located in the CX Core Mixed Use district; and

WHEREAS, while the liquor establishment was a permitted use in the Downtown district in 1993, now known as the CX Core Mixed-Use district, the second floor apartment was a legal nonconforming use and required a special use permit to make proposed renovations to the interior and exterior of the building; and

WHEREAS, subsequent to the adoption of Village Ordinance #33- -Z-2341, Chapter 118 of the Skokie Village Code was amended to allow second floor apartmerus in the CX Core Mixed-Use district as a permitted use; and

WHEREAS, the petitioner now desires to make modifications to the site plan and add outdoor dining to the Subject Property, which would not be allowed by the current special use permit; and

WHEREAS, the Director of Community Development has recommended that special use permit Ordinance 93-1-Z-2341 be repealed since it is no longer needed and the proposed improvements to the site are in compliance with Village Code requirements; and

WHEREAS, the Mayor and Board of Trustees, at a public meeting duly held on November 5, 2012, concurred in the aforesaid recommendation of the Director of Community Development;
