**STATEMENT OF LIEN

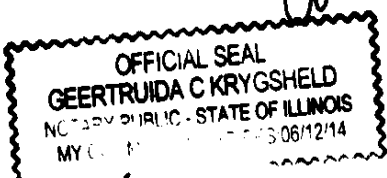
