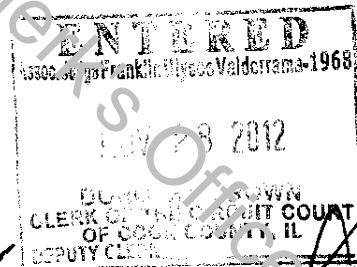

JUDGMENT ORDER

This matter coming to be heard on Plaintiff's Motion for Partial Summary Judgment (on Counts III and IV); it is hereby ORDERED:

1. Plaintiff's Motion for Partial Summary Judgment is granted.

2. Judgment is entered in favor of Plaintiff Jimmie Sanders and against Defendants Warren Jackson, et al. Paschal, Yolanda J. King, and PTV Inc., on Count III (Illinois Consumer Fraud Act) and Count IV (Common Law Fraud).

3. Based on the above, money damages are entered against the above Defendants, who are jointly liable for some of the amount of \$86,400 (Eighty-Six Thousand Four Hundred Dollars).

4. Plaintiff dismisses voluntarily Count V with prejudice.

5. This judgment order resolves all outstanding claims and represents a final and appealable judgment of this case in its entirety.
