Section 3 for the Periodic Payment to Lender of the yearly premium installments for property insurance on the Property; and (ii) Borrower's obligation under Section 5 to maintain property insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owners Association policy.

What Leider requires as a condition of this waiver can change during the term of the

loan. Borrower shall give Lender prompt notice of any lapse in required property insurance coverage provided by the master or blanket policy.
