



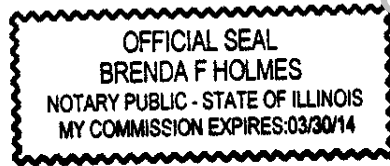
WHEREFORE, the District does hereby release its lien against the real estate described herein.
