MODIFICATION ACREMENT (Mortgage)

This Modification Agreement (Mortgage) ("Modification Agreement") is made as of December 15, 2012, by THX Ronnie, LLC, an Illinois limited liability company ("Mortgager") and LaSalle Bank National Association, now known as Bank of America, N.A., a national banking a sociation ("Mortgagee").

Factual Background

- A. Mortgagor executed a certain Mortgage (the "Mortgage") for the benefit of Nortgagee, dated December 15, 2005, and recorded on January 3, 2006, as Instrument Number 0000/16/20! Official Records of Cook County, State of Illinois. The Mortgage encumbers the real property described in Exhibit "A" attached hereto and incorporated herein.
 - B. Mortgagor and Mortgagee desire to amend the Mortgage as set forth below.

Agreement

Therefore, Mortgagor and Mortgagee agree as follows:

1. All capitalized terms not otherwise defined herein shall have the meanings given to them in the Mortgage. Mortgagee is sometimes referred to herein as "Lender" and Mortgagor is sometimes referred to herein as "Grantor".

2. The Indebtedness secured by the Mortgage has changed or has been modified. Accordingly, the definition of "Note" in the Mortgage is hereby modified to read as follows in its entirety:

> Note. The word "Note" means that certain Promissory Note dated December 15, 2005, in the original principal amount of Three Hundred Sixty Thousand and 00/100 Dollars (\$360,000.00) from Grantor to Lender (the "Note"), as amended by (i) a certain Loan Modification Agreement dated December 15, 2010 (the "Loan Modification Agreement No. 1"), further amended by (ii) a certain Loan Modification Agreement dated December 27, 2011 (the "Loan Modification Agreement No. 2"), and further amended by (iii) a certain Loan Modification Agreement dated December 15, 2012 (the "Loan Modification Agreement No. 3"), together with interest at Lender's Prime Rate plus 3.000 percentage points as defined in the Loan Modification greement No. 1, and all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the Note. The maturity date of the Note is June 6, 2013, except as may be accelerated pursuant to the terms of the Note, the Related Documents, or hereof; provided, that to the extent that the maturity date is extended, amended or modified from time to time under the Note or any related document, the maturity date hereunder shall also be so extended, amended or modified, but in no circumstances will this Mortgage secure the Indebtedness beyond 20 years from the maturity date set forth above unless this Mortgage is modified to reflect a new maturity date.

- 3. Except as provided in this Modification Agreement, the terms of the Mortgage remain in full force and effect.
- 4. Notwithstanding anything to the contrary contained herein, in no way shall the addition of the maturity dates and interest rates to the Mortgage adversely affect the priority or validity of the Mortgage, and the parties hereto agree that said additional terms shall be effective as of the original date of the Mortgage.
