Limited Power of Attorney

This Limited Power of Attorney is executed as of January 5, 2011, by Citigroup Global Markets Realty Corp. having an office at 390 Greenwich Street, New York, NY 10013 ("Owner"), appointing as attorney-in-fact American Home Mortgage Servicing, Inc., having an office at 4600 Regent Boulevard, Suite 200, Irving, TX 75063("AHMSI").

RECITALS:

- Owner and AHMSI entered into a Servicing Agreement ("Servicing Agreement") effective as of A. June 25, 2008, pursuant to which AHMSI will service certain mortgage loans and/or REO Properties as more particularly de cribed on the schedule provided to AHM by Owner (collectively, "Mortgage Loans") on behalf of the Owner;
- In conjection with AHMSI's performance of such functions, AHMhas requested that the Owner B. authorize AHM to execu covertain documents on the Owner's behalf as further described herein.

AHM is authorized to act as attorney-in-fact in the following limited circumstances:

Owner hereby appoints ARMSI as its attorney-in-fact, with full power of substitution, to exercise at any time all or any of the following powers: (') to execute on behalf of Owner any documents or instruments necessary to collect payments against, to liquidate or cance! any mortgage subject to the Servicing Agreement in accordance with such Servicing Agreement, and to otherwise murage and service the Mortgage Loans and properties in accordance with the Servicing Agreement; (ii) to execute on behalf of Owner any assignments, documents or instruments necessary to assign, convey, or otherwise transfer it, interest in the Mortgage Loans as per the Servicing Agreement; (iii) to execute documents on behalf of Ow ier in connection with any bankruptcy or receivership of a mortgagor whose Mortgage Loan is subject to the Servicin, Agreement; (iv) to execute on behalf of Owner any documents necessary to carry out foreclosure of any mortgaged property securing a Mortgage Loan subject to the Servicing Agreement, (v) to execute on behalf of the Owner any necessary documents to effectuate an eviction, unlawful detainer or similar dispossessory proceeding, and (vi) to execute on behalf of Owner any documents necessary for the offer, listing, closing of sale and conveyance of real estate owned ("REO") property in accordance with the terms of the Servicing Agreement. This limited power of attorne, is not intended to extend the powers granted to AHMSI under the Servicing Agreement or to allow AHMSI to take rany action with respect to a Mortgage Loan not authorized by the Servicing Agreement.

- Owner represents that any bank, title company, courts, governmental agencies, or other institutions may rely on this Limited Power of Attorney in honoring the acts of AHMSI hereunder.
- AHMSI hereby agrees to indemnify and holdthe Owner and its directors, officers employees and D. agents harmless from and against any and all liabilities, obligations, losses, damages, penalties, actions, judgments, suits, costs, expenses or disbursements of any kind or nature whatsoever incurred byreason or result of or in connection with the exercise by AHMSI of the powers granted to it hereunder. The foregoing indemnity shall survive the termination of this Limited Power of Attorney.

This Limited Power of Attorney is entered into and shall be governed by the laws of the state of New York. To the extent permitted by other applicable law, the terms and provisions of this Agreement shall control in the event of any conflict between such terms or provisions.
