NOTICE AND CLAIM OF COMMERCIAL REAL ESTATE BROKER'S LIEN

Shai Town Realty Group, Inc., an Illinois corporation ("Broker"), whose real estate license number is 475.118273, and whose business address is 4116 W. Peterson Ave., Chicago, IL 60646, hereby claims a Commercial Real Estate Broker's Lien in accordance with the Commercial Real Estate Broker Lien Act, 770 ILCS 15/1 et seq. as to the real estate described below and states as follows:

- 1. The real estate and improvements thereon as to which the lien is claimed ("Real Estate") is a mixed commercial and residential real estate building with less than six residential units located in Cook County, State of Illinois, at the address commonly known as 1439 North Milwaukee Avenue, Chicago, IL 60622 and is legally described in Exhibit A, attached hereto.
- 2. The Real Estate was at all relevent times herein owned by Jose A. Pulido and Maria Pulido ("Owners").
- 3. The Broker entered into a Showing and Compensation Agreement with the Owners dated March 15, 2012 (the "Commission Agreement"). Pursuant to the Commission Agreement, the Owners granted the Broker the right to a commission payment of five percent (5%) of the Real Estate sales price should the Broker show the Real Estate to a client that resulted in an offer to purchase the Real Estate.
- 4. The Broker provided the licensed services to the Owners by skowing the Real Estate resulting in an accepted offer to purchase the Real Estate for one million one hundred fifty thousand dollars (\$1,150,000.00) in accordance with the terms and provisions set forth in the Commission Agreement, and the Broker is entitled to be paid a commission under the Commission Agreement.
- 5. The Broker is entitled to a commission of fifty-seven thousand five hundred dollars (\$57,500.00).
- 6. The Broker now claims a lien on the Real Estate as of January 17, 2013 in the amount of fifty-seven thousand five hundred dollars (\$57,500.00) plus court costs and reasonable attorney's fees.
