THIS MORTGAGE, ASSIGNMENT OF RENTS, SECURITY AGREEMENT AND FIXTURE FILING (the "Instrument") is made to be effective this 23<sup>rd</sup> day of January 2013 between Rashad Muhammad whose address is 120-122 North Kilpatrick Chicago, Illinois as trustor ("Borrower") and Woodbridge Mortgage Investment Fund 1, LLC as beneficiary ("Lender"):

Borrower is indebted to Lender in the principal amount of One Hundred Fifty-Nine Thousand Dollars 0(/1)0 (\$159,000.00) as evidenced by the Note payable to Lender dated as of the date of this Instrument, and maturing on January 22, 2014 (the "Maturity Date"):

- e. "Environmental Permit" means any permit, license, or other authorization issued under any Hazardous Materials Law with respect to any activities or businesses conducted on or in relation to the Property.
- f. "Event of Default" means the occurrence of any event listed in Section 21.

v. For purposes of defining the term Transfer, the term "partnership" shall mean a general partnership, a limited partnership, a joint verture and a limited liability partnership, and the term "partner" shall mean a general partner, a limited partner and a joint venturer.

- 2. <u>Payment of Indebtedness; Performance under Loan Documents</u>. Borrower shall pay the Indebtedness when due in accordance with the terms of the Note and the other Loan Documents and shall perform, observe and comply with all other provisions of the Note and the other Loan Documents.
- 3. Uniform Commercial Code Security Agreement.

Instrument (and any financing statement which may be filed in connection with this Instrument) as Lender may require, Borrower shall not (i) change its name, identity, structure or jurisdiction of organization; (ii) change the location of its place of business (or chief executive office if more than one place of business); or (iii) add to or change any location at which any of the Property is stored, held or located.

- c. If an Event of Default has occurred and is continuing, Lender shall have the remedies of a secured party under the Uniform Commercial Code, in addition to all remedies provided by this Instrument or existing under applicable law. In exercising any remedies, Lender may exercise its remedies against the UCC Collateral separately or together, and in any order, without in any way affecting the availability of Lender's other remedies.
- d. Thi. Instrument constitutes and is filed as a fixture filing under the DCC covering the Property which now or in the future consists of goods comprising part of the Property which are or are to become distures upon the subject real estate. For the purposes of this fixture filing and the filing of this Instrument as a financing statement, the "debtor" is the Borrower, the "secured party" is Lender, and the real estate upon which the fixtures and/or other items are located is the Land. - 4. Assignment of Rents; Appointn en of Receiver; Lender in Possession.
  - a. As part of the consideration for the midebtedness, Borrower absolutely and unconditionally assigns and transfers to Lender all Rents. It is the intention of Borrower to establish a present, absolute and irrevocable transfer and assignment to Lender of all Rents and to authorize and empower Lender to collect and receive all Rents without the necessity of further action on the part of Borrower. Promptly upon request by Lender. Borrower agrees to execute and deliver such further assignments as Lender may from time to time require. Borrower and Lender intend this assignment of Rents to be immediately effective and to constitute an absolute present assignment and not an assignment for additional security only. For purposes of giving effect to this absolute assignment of Rents, and for no other purpose, Rents shall not be deemed to be a part of the Property. However, if this present, absolute and unconditional assignment of Rents is not entorceable by its terms under the laws of the Property Jurisdiction, then the Rents shall be included as a part of the Property and it is the intention of the Borrower that in this circumstance this Instrument create and perfect a lien on Rents in favor of Lender, which lien shall be effective as of the date of this Instrument.
  - b. After the occurrence of an Event of Default and during the continuance of suck Event of Default. Borrower authorizes Lender to collect, sue for and compromise Rents and cirects each tenant of the Property to pay all Rents to, or as directed by, Lender. Borrower shall not collect or accept payment of any Rents more than two months prior to the due cates of such Rents.

d. If an Event of Default has occurred and is continuing. Lender may, regardless of the adequacy of Lender's security or the solvency of Schower and even in the absence of waste, enter upon and take and maintain full control of the Property in order to perform all acts that Lender in its discretion determines to be necessary or desirable for the operation and maintenance. of the Property, including the execution, cancellation or medification of Leases, the collection of all Rents, the making of repairs to the Property and the executive or termination of contracts providing for the management, operation or maintenance of the Property, for the purposes of enforcing the assignment of Rents pursuant to Section 4(a), protecting the Property or the security of this Instrument, or for such other purposes as Lender in its discretion may deem necessary or desirable. Lender or the receiver, as the case may be, shall be entitled to receive a reasonable fee for managing the Property. Immediately upon appointment of a receiver or immediately upon the Lender's entering upon and taking possession and control of the Property, Borrower shall surrender possession of the Property to Lender or the receiver, as the case may be, and shall deliver to Lender or the receiver, as the case may be, all documents, records (including records on electronic or magnetic media), accounts, surveys, plans, and specifications relating to the Property and all security deposits and prepaid Rents. In the event Lender takes possession and control of the Property, Lender may exclude Borrower and its representatives from the Property. Borrower acknowledges and agrees that the exercise by Lender of any of the rights conferred under this Section 4 shall not be construed to make Lender a mor gagee-in-possession of the Property so long as Lender has not itself entered into actual possession of the Land and Improvements.

- e. If Lende: enters the Property, Lender shall be liable to account only to Borrower and only for those Rents actually received. Except to the extent of Lender's gross negligence or willful misconduct, Lender shall not be liable to Borrower, anyone claiming under or through Borrower or anyone having an interest in the Property, by reason of any act or omission of Lender under Section 4(d), and Borrower bereby releases and discharges Lender from any such liability to the fullest extent permitted by law.
- f. If the Rents are not sufficient to meet the costs of taking control of and managing the Property and collecting the Rents, any runds expended by Lender for such purposes shall become an additional part of the Indebtedness under Section 9.
- g. Any entering upon and taking of control of the Property by Lender or the receiver, as the case may be, and any application of Rents as previded in this Instrument shall not cure or waive any Event of Default or invalidate any other right or remedy of Lender under applicable law or provided for in this Instrument.
- 5. Assignment of Leases; Leases Affecting the Property.
  - a. As part of the consideration for the Indebtedness, Borrower absolutely and unconditionally assigns and transfers to Lender all of Borrower's right, title and interest in, to and under the Leases, including Borrower's right, power and authority to modify the terms of any such Lease, or extend or terminate any such Lease. It is the intention of Borrower to establish a present, absolute and irrevocable transfer and assignment to Lender of all of Borrower's right, title and interest in, to and under the Leases. Borrower and Lender intend this assignment of the Leases to be immediately effective and to constitute an absolute present assignment art, not an assignment for additional security only. For purposes of giving effect to this absolute assignment of the Leases, and for no other purpose, the Leases shall not be deemed to be a part of the Property. - d. If Borrower is unwilling or unable to provide such certification. Lender may require a professional inspection of the Property at Borrower's expense.
- 11. Books and Records. Borrower shall keep and maintain at all times and upon Lender's request shall make available to Lender complete and accurate books of account and records (including copies of supporting bills and invoices) adequate to reflect correctly the operation of the Property, and copies of all written contracts, Leases, and other instruments which affect the Property. The books, records, contracts, Leases and other instruments shall be subject to examination and inspection by Lender at any reasonable time. Borrower authorizes Lender to obtain a credit report on Borrower at any time. If an Event of Default has occurred and is continuing, Borrower shall deliver to Lender upon written demand all books and records relating to the Property or its operation.
- 12. Payment of Taxes, Assessments, Expenses, and Other Charges.
  - a. Subject to Section 14, Borrower shall pay before a penalty might attach for nonpayment thereof, all tayes and assessments and all other charges whatsoever levied upon or assessed or placed against the Property, except that assessments may be paid in installments so long as no fine or penalty is added to any installment for the nonpayment thereof. Any such notice given by Borrower shall not relieve Borrower of, or result in a waiver of, any obligation under this Instrument, the Note, or any other Loan Document.

Without limiting the generality of the previous sentence, Borrower shall (i) obtain and maintain all Environmental Permits required by Hazardous Materials Laws and comply with all conditions of such Environmental Permits; (ii) cooperate with any inquiry by any Governmental Authority; and (iii) comply with any governmental or judicial order that arises from any alleged Prohibited Activity or Condition.
- f. - ii. <u>Worker's Compensation Insurance</u>. While any improvement is in the course of being constructed, renovated or rebuilt on any Property, such workers' compensation insurance as is required by statute.
