- 1. Owner(s) now holds title to that certain real property in the County of Cook, State of Illinois (the "Property"), to wit:

On or about October 27, 2012 Claimant and Owner(s) entered into that certain agreement (the "Contract") for the performance of certain work and/or the delivery of certain materials by Claimant (the "Work") for the sum of One Thousand, One Hundred, Forty-seven Dollars (\$1,147.00) (the "Contract Sum").
- 3. On or about November 26, 2012, Claimant completed all of the Work under the terms of and in accordance with the Contract, in that Claimant supplied all labor and materials necessary for performance of its duties under the Contract for the improvements to the Property. The Work consisted of the following: Replace upper and lower gutters, one sheet of plywood, three vents, and damaged shingles.

All of the labor and materials furnished and delivered by Claimant were furnished to and used in connection with the improvement of the Property, and the last of such labor and materials was furnished, delivered and performed, and the work contemplated under the Contract completed, on or about November 26, 2012.
- 5. There is now justly due and owing the Claimant after allowing to the Owner(s) all credits, deductions and offsets, the sum of Eight Hundred, Ninety Dollars (\$890.00) plus interest at the rate specified in the Illinois Mechanics Lien Act.
- 6. Claimant now claims a lien on the above-described Property, and on all of the improvements therein for of Eight Hundred, Ninety Dollars (\$890.00) plus interest at the rate specified in the Illinois Mechanics Lien Act, as well as court costs and attorney fees.
