- 3. The Amendment dated December 15, 2003 given by Borrower to Assignor and recoded in the Office of the Cook County Recorder of Deeds, in the State of Illinois on January 2, 2004 as document number 0400242191;
- 4. The Subordination Agreement recorded as document number 0409204160 on April 1, 2004;
- 5. The Subordination Agreement recorded as document number 0627805335 on October 5, 2006;
- 6. The Subordination Agreement recorded as document number 0911240048 on April 22, 2009; and
