#### Borrower promises and agrees:

- 1. To keep the Property in good repair, and to comply with all laws and ordinances, which affect the Property.
- 2. To pay all taxes, assessments, and water bills levied on the Property and any other amounts which could become a senior Security Interest against the Property. "Security Interest" includes any lien, mortgage or other encumbrance.

The notice shall further inform Borrower citie right to reinstate after acceleration and the right to assert in the foreclosure proceeding the non-existence of a default or any other defense of Borrower to acceleration and forcelosure. If the default is not cured on or before the date specified in the notice, Lender at its option may require immediate payment in full of all sums secured by this Security Instrur, ont without further demand and may foreclose this Security Instrument by judicial proceeding.
