GRANTEE accepts title to the premises, subject to the covenants, conditions, and restrictions set forth in that certain Redevelopment Agreement, dated as of January 18, 2013 and recorded with the Cook County Recorder of Deeds on January 24, 2013 as Document Number 1302416040, which shall constitute covenants running with the land in favor of the City of Chicago and forming a part of the consideration for the conveyance of the subject premises.
