That part of the North ½ of Cynthia Robinson's Tract, lying West of the center of Des Plaines River Road, in the Partition of the North Section of Robinson's Reservation, in Township 40 North, Range 12, East of the Third Principal Meridian, described as follows: Beginning on a line 50 feet West of the center line of said River Road, and 200 feet South of the North line of Section 15, also being the center of Lawrence Avenue; thence Northwesterly 23.62 feet to a point on a line 190 feet South and parallel with the North line of said section; thence West on last mentioned parallel line, a distance of 180 feet to a point 250 feet West of and parallel with the center of said River Road; thence South on last mentioned parallel line to the South line of the North ½ of said Cynthic, Robinson's Tract; thence East on the South line of said tract, to a point 50 feet West of the Center line of said River Road; thence North along a line 50 feet West of and parallel with the center line of River Road to the place of heginning, in Cook County, Illinois.
