Before each Change Date, the Note Holder will calculate my new interest rate by adding Four and 750/1000

percentage points (4.750 %) to the Current index. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.
