If Borrower abandons the Property, Lender may file, negotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. (B) The Index

B. TRANSFER OF THE PROPERTY OR A BENEFICIAL INTEREST IN BORROWER
