The definition of the Note is hereby amended to read as follows:

The Promissory Note dated January 1, 2013, in the original principal amount of \$83,116.95 from Borrower to Lender, together with all renewals of, extensions of, modifications of, refinancing of, consolidations of, and substitutions for the promissory note or agreement. The interest rate on the Note is a variable interest rate based upon an index. The index currently is 3.250% per annum. Interest on the unpaid principal balance of the Note will be calculated using a rate of 1.000 percentage point over the Index, adjusted if necessary for any minimum and maximum rate limitations described below, resulting in an initial rate of 6.000% based on a year of 360 days. Payments on the Note are to be made in accordance with the following payment schedule: in one principal payment of \$83,116.95 plus interest on January 1, 2014. This payment due on January 1, 2014, will be for all principal and all accrued interest not yet paid. In addition, Borrower will pay regular monthly payments of all accrued unpaid interest due as of each payment date, beginning Fourtary 1, 2013, with all subsequent interest payments to be due on the same day of each month after that If the index increases, the payments tied to the index, and therefore the total amount secured hereunger, will increase.
