### ORDINANCE NO. 2013-3-13 B

#### AN ORDINANCE CHANGING THE NAME OF ROSE STREET TO FASHION OUTLETS WAY

WHEREAS, the street formerly known as Rose Street was dedicated by a Plat of Dedication, recorded in the Office of the Cook County Recorder of Deeds on or about October 30, 2008, as Document No. 08030419051, and by a Plat of Resubdivision for the Rosemont Outlet Mall Resubdivision, recorded on or about February 27, 2012, as Document No. 1205813031; and

WHEREAS, Rose Street runs from the corporate limits of the Village on the south to an intersection with Balmoral Avenue on the north in the Village of Rosemont; and

WHEREAS, the corporate authorities of the Village of Rosemont have determined that Rose Street, running from the corporate limits of the Village on the south to Balmoral Avenue on the north, as depicted on the Plat of Resubdivision of the Rosemont Outlet Mall Resubdivision recorded in the Office of the Cook County Recorder of Deeds on February 27, 2012, as Document No. 1205813031, should be renamed as "Fashion Outlets Way."

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROSEMONT, COOK COUNTY, ILLINOIS, in the exercise of its home rule powers, as follows:

SECTION 1: The name of the street now named "Rose Street" running from the corporate limits of the Village on the south to Balmoral Avenue on the north in the Village of Rosemont, as designated on the Plat of Resubdivision of the Rosemont Outlet Mall Resubdivision recorded in the Office of the Cook County Recorder of Deeds on February

27, 2012, as Document No. 1205813031, and on various other recorded documents, shall be and hereby is changed to "Fashion Outlets Way".

SECTION 2: That the Village Clerk of the Village of Rosemont is hereby authorized and directed to cause a certified copy of this Ordinance to be recorded in the Office of the Cook County Recorder of Deeds.

SECTION 3: This ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the Village of Rosemont that to the extent that the terms of this ordinance should be inconsistent with any non-preemptive state law, that this ordinance shall supersede state law in that regard within its jurisdiction.

SECTION 4: This ordinance shall be in full force and effect upon its passage and approval and shall subsequently be published in pamphlet form as provided by law.


