THIS SUBORDINATION OF LIEN (this "Agreement") is dated this 30th day of January, 2013, and is executed by PARK RIDGE COMMUNITY BANK, ("Subordinating Lender") for the benefit of BANK OF AMERICA, Its Successors And / Or Assigns ("Senior Lender").

WITNESSETH

WHEREAS, Michael J. Yadgar and Susan E. 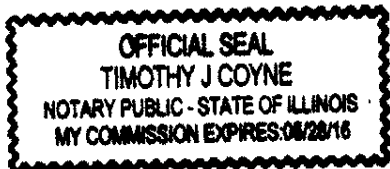
