

Schedule A-2 New York Property:

All that certain plot, piece or parcel of land, situate, lying and being in the Borough of Manhattan, City, County and State of New York, bounded and described as follows:

BEGINNING at a point on the southerly side of 45th Street distant 400 feet easterly from the corner formed by the intersection of the southerly side of 45th Street and the easterly side of Avenue of the Americas (formerly 6th Avenue).
