#### Borrower promises and agrees:

- 1. To keep the Property in good repair, and to comply with all laws and ordinances, which affect the Property.

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: 2946 N SHEFFIELD

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Porrower's interest.

In addition to the cryenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

- A. Condominium Obligation . Rorrower shall perform all of Borrower's obligations under the Condominium Project's Constituent Locuments.
