## DEED IN TRUST

THE GRANTOR, LIDIA TOKARCZYK, under the provisions of a deed or deeds in trust, duly recorded and delivered to said trustee in pursuance of and under and by virtue of the terms and provisions of a certain trust agreement dated the 4<sup>th</sup> day of November, 2009, and designated as the TOKARCZYK FAMILY REVOCABLE TRUST, for and in consideration of the sum of Ten Dollars and other good and valuable consideration, receipt of which is hereby acknowledged, hereby conveys and warrants (i) an undivided 25% interest to LIDIA TOKARCZYK, and her successors, as Trustee under the provisions of a trust agreement dated the 4<sup>th</sup> day of November, 2009, and designated as the "GEORGE TOKARCZYK RESIDUARY TRUST", and unto all and every successor or successors in trust under said Residuary Trust, and (ii) an undivided 25% interest to LIDIA TOKARCZYK, and her successors, as Trustee under the provisions of a trust agreement dated the 4<sup>th</sup> day of November, 2009, and designated as the "LIDIA TOKARCZYK TRUST", and unto all and every successor or successors in trust under said Lidia Tokarczyk Trust, as tenants in common, in and to the following described real estate in the County of Cook, State of Illinois, to wit:

premises; for cash or on credit, at public or private sales; to exchange the premises for other property; to grant options to purchase the premises; and to determine the prices and terms of sales, exchanges and options.

In no case shall any party dealing with said trustee in relation to said premises, or to whom said premises or any part thereof shall be conveyed, contracted to be sold, leased or mortgaged by said trustee, be obliged to see to the application of any purchase money, rent, or money borrowed or advanced on said premises, or be obliged to see that the terms of this trust have been complied with, or be obliged to inquire into the necessity or expediency of any act of said trustee, or be obliged or privileged to inquire into any of the terms of said trust agreement; and every deed, trust deed, mortgage, lease or other instrument executed by said trustee in relation to said real estate shall be conclusive evidence in favor of every person relying upon or claiming under any such conveyance, lease or other instrument, (a) that at the time of the delivery thereof the trust created by this Indenture and by said trust agreement was in full force and effect; (b) that such conveyance or other instrument was executed in accordance with the trusts, conditions and limitations contained in this Indenture and in said trust agreement or in some amendment thereof and binding upon all beneficiaries thereunder; (c) that said trustee was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument; and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessor in trust.

This Deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said Trustee by the terms of said deed or deeds in trust delivered to said Trustee in pursuance of the Trust Agreement above mentioned.

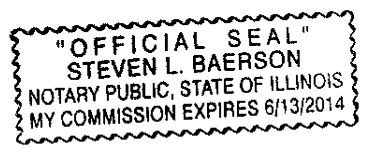

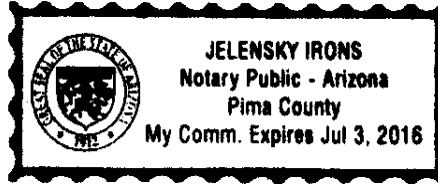

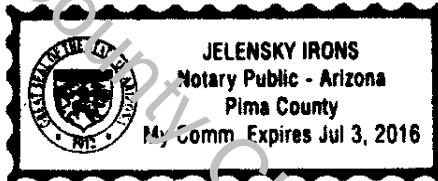
