- 13. Notices. The notice shall be directed to the Property Address or any other address Borrower designates by notice to Lender. - 16. Hazardous substances. Borrower shall not cause or permit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property. Borrower shall not do, nor allow anyone else to do, anything affecting the Property that is in violation of any Environmental Law.
