Be It Ordained by the City Council of the City of Chicago:

SECTION 1.

Vacation:

That part of the north and south 20 foot wide public alley lying east of and adjacent to Lots 13 through 16, both inclusive, lying south of the easterly extension of the north line of the south 20 feet of Lot 17 and lying north of the north line of East 58th Street, all in Block 4 in Marshall Field's Addition to Chicago in the east half of the northwest quarter of Section 14, Township 38 North, Range 14 East of the Third Principal Meridian, according to the plat the eof recorded June 27,1890 as Document Number 1293992, in Cook County, Illinois.

Dedication:
