DEFINITIONS

The following words and 'erris as well as the other words and terms used in this document, shall have the meaning indicated for each. Certain rules regarding the usage of words used in this document are set forth below in one or more sections (f this document.

"Security Instrument" means this document, which is dated May 3, 2013, together with all attachments and riders to this document, and any other document executed by the Borrower in connection with the Loan.

"Borrower" is Value Properties, Inc., a Illinois Corroration. Borrower's address is 2720 Des Plaines Road, Suite 34, Des Plaines, IL 60018. Borrower is the monorgor under this Security Instrument.

"Lender" is HomeVestors Investments, Inc.. Lenders add.ess is 6500 Greenville Avenue, Suite 400, Dallas, Texas 75206. Lender is the mortgagee under this Security Instrument.

"Note" means the promissory note signed by Borrower and dated the same date as this Security Instrument. The Note states that Borrower owes Lender U.S. \$83,075.00 (not) interest. Borrower has promised to pay this debt in regular Periodic Payments and to pay the debt in full not later than the maturity date specified in the Note.

"Property" means the following real and personal property:

- b. extinguishing apparatus, kitchen equipment, cafeteria equipment, all of which to the extent permitted by law are hereby understood and agreed to be part and parcel of the Property and improvements thereon and appropriated to the use and operation of the Property and said improvements, and whether affixed or annexed or not, shall for the purposes of this Security Instrument be deemed constructively to be real estate and conveyed hereby, excluding, however, readily movable trade fixtures not used or acquired for use in connection with the operation of any such building or any part thereof, readily movable office furniture, furnishings and equipment not so used or acquired for use, and consumable supplies, whether or not affixed or annexed, that have been or that may hereafter be placed in any building constructed upon the Property or any part thereof.

"Periodic Payment" means the regularly scheduled amount due for (I) principal and interest under the Note, plus (ii) any amounts which may be advanced or paid by Lender or Trustee under any other provision of this Security Instrument on account of the failure of Borrower to comply with any covenant contained herein.

TRANSFER OF RIGHTS IN THE PROPERTY

This Security Instrument secures to Lender: (i) the repayment of the Loan, and all renewals, extensions and modifications of the Note; and (ii) the performance of Borrower's covenants and agreements under the Security Instrument and Note. For this purpose, Borrower does hereby mortgage, grant and convey the Property to Lender, and Lender's successors and assigns, with power of sale. To Have and To Hold the Property unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the Property, and all easements, appurtenances, and fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument.

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower accounts and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

UNIFORM COVENANTS. Remover and Lender covenant and agree as follows:

1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Any application of payments, insurance proceeds, or Miscellaneous Proceeds to principal due under the Note shall not extend or postpone the due date, or change the amount, of the Periodic Payments.

The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower. Unless Lender and Borrower otherwise agree in writing, any insurance proceeds, whether or not the underlying insurance was required by Lender, shall be applied to restoration or repair of the Property, if the restoration or repair is economically feasible and Lender's security is not lessened. During such repair and restoration period, Lender shall have the right to hold such insurance proceeds until Lender has had an opportunity to inspect such Property to ensure the work has been completed to Lender's satisfaction, provided that such inspection shall be undertaken promptly. Lender may disburse proceeds for the repairs and restoration in a single payment or in a series of progress payments as the work is completed. Unless an agreement is made in writing or Applicable Law requires interest to be paid on such insurance proceeds, Lender shall not be required to pay Borrower any interest or earnings on such proceeds. However, any Borrower who co-signs this Security Instrument but does not execute the Note (a "co-signer"): (a) is co-signing this Security Instrument only to mortgage, grant and convey the co-signor's interest in the Property under the terms of this Security Instrument; (b) is not personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower can agree to extend, modify, forbear or make any accommodations with regard to the terms of this Security Instrument or the Note without the co-signer's consent.

Subject to other provisions herein, Successor in Interest of Borrower who assumes Porrower's obligations under this Security Instrument in writing, and is approved by Lender, shall obtain all of Borrover's rights and benefits under this Security Instrument. Borrower shall not be released from Borrower's obligation and liability under this Security Instrument unless Lender agrees to such release in writing. - 16. Acceleration; Remedies. Lender shall give notice to Borrower prior to acceleration following Borrower's breach of any covenant or agreement in this Security Instrument (but not prior to acceleration under the applicable section hereof unless Applicable Lany provides otherwise). The notice shall specify: (a) the default; (b) the action required to cure the default; (c) a date, not less than 30 days from the date the notice is given to Borrower, by which the default must be cured; and (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Security Instrument, foreclosure by judicial proceeding and sale of the Property. This Security Instrument also secures and enforces all other indebtedness or obligations now existing or subsequently created from the Borrower to the Lender, regardless of the manner by which the indebtedness is evidenced or created, whether by notes, advances, contracts, agreements, bookkeeping entries or otherwise. Default in the payment or performance of any of the other indebtedness or obligations shall constitute a breach under this Security Instrument to the same extent and with the same force and effect as a default in the payment of the Note or the performance of Borrower's other obligations herein.
- 22. Further Assurances. Borrower will execute and deliver such furthar instruments and do such further acts as may be necessary or desirable or as may be reasonably requester by the Lender to carry out more effectively the purposes of this Security Instrument and to subject to the lien created hereby any properties, rights and interests covered or intended to be covered hereby.
- 23. Nature of Security Instrument.
