This Agreement shall inure to the benefit of Junior Lien Holder and be binding upon Subordinator, its successors and assigns and shall be binding upon uny purchaser (at foreclosure or otherwise) of the Property, or any part thereof, and their respective peirs, personal representatives, successors and assigns.
