SUBORDINATION AGREEMENT

This Subordination Agreement made as of the 21st day of May 2013, by Gold Coast Bank, having an address of 1201 N. Clark Street #204, Chicago IL 60610 ("Subordinator"), and Gold Coast Bank, its successors and/or assigns as their interest may appear a corporation organized and existing under the laws of the State of Illinois with its principal place of business at 1201 N.
