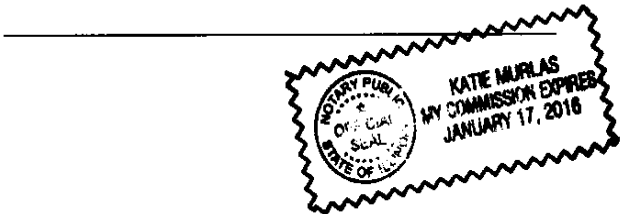

EXHIBIT B

PERMITTED EXCEPTIONS
