LIMITED POWERS OF ATTORNEY FROM INDENTURE TRUSTEE

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, pursuant to that certain Amended and Restated Property Management and Lease Servicing Agreement, dated as of March 4, 2005, as amended by that certain Amendment No. 1 to Amended and Restated Property Management and Lease Servicing Agreement, dated as of February 21, 2007 and that certain Amendment No. 2 to Amended and Restated Property Management and Lease Servicing Agreement, dated as of August 21, 2007 (the "Agreement"), among NET LEASE FUNDING 2005, LP, as Issuer (the "Issuer"), GE Capital Franchise Finance Corporation, successor in interest to Trustreet Financial Services, LP, formerly known as CNL Financial Services, LP, as property manager (the "Property Manager") and special servicer (the "Special Servicer"), WELLS FARGO BANK, N.A., as indenture truster (the "Indenture Trustee"), the Property Manager and Special Servicer (hereafter, the "Servicer") administers and services certain "Mortgaged Properties" and "Leases" as such terms are defined in the Agreement, in accordance with the terms of the Agreement and such Leases, and,
