If (a) Borrower fails to perform the covenants and agreements contained in this Security Instrument, (b) there is a legal proceeding that might significantly affect Lender's interest in the Property and/or rights under this Security Instrument (such as a proceeding in bankruptcy, probate, for condemnation or forfeiture, for enforcement of a lien which may attain priority over this Security Instrument or to enforce laws or regulations), or (c) Borrower has abandoned the Property, then Lender may do and pay for whatever is reasonable or appropriate to protect Lender's interest in the Property and rights under this Security Instrument, including protecting and/or assessing the value of the Property, and securing and/or repairing the Property. If Lender required Mortgage Insurance as a condition of making the Loan and Rorrower was required to make separately designated payments toward the premiums for Mortgage Insurance, Borro ver shall pay the premiums required to maintain Mortgage Insurance in effect, or to provide a non-refundable loss greeve, until Lender's requirement for Mortgage Insurance ends in accordance with any written agreement between berr wer and Lender providing for such termination or until termination is required by Applicable Law.
