Maintener ce of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended contrage endorsements on a replacement basis for the full insurable value covering all Improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. Grantor shall also procure and maintain comprehensive general Pability insurance in such coverage amounts as Lender may request with Lender being named as adultional insureds in such liability insurance policies. Additionally, Grantor shall maintain such other insurance, including but not limited to hazard, business interruption and boiler insurance as Lender may require. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grai for shall deliver to Lender certificates of coverage from each insurer containing a stipulation that cove age will not be cancelled or diminished without a minimum of fifteen (15) days' prior written notice to Lender and not containing any disclaimer of the insurer's liability for failure to give such notice. Each insurance polic; also shall include an endorsement providing that coverage in favor of Lender will not be impaired in any way, by Eny act, omission or default of Grantor or any other person. Should the Real Property be located in an Free designated by the Director of the Federal Emergency Management Agency as a special flood hazard are a cantor agrees to obtain and maintain Federal Flood Insurance, if available, for the full unpaid principa balance of the loan and any prior liens on the property securing the loan, up to the maximum policy limits set under the National Flood Insurance Program, or as otherwise required by Lender, and to maintain such insured of the term of the loan.

Application of Proceeds. Grantor shall promptly notify Lendon of any loss or damage to the Property. Lender may make proof of loss if Grantor fails to do so within fifther (15) days of the casualty. TAX AND INSURANCE RESERVES. Grantor agrees to establish and maintain a reserve account to be retained from the initial proceeds of the loan evidenced by the Note in such amount deemed to be sufficient by Lender to (A) create an adequate cushion and (B) provide enough funds to be in a position to make timely payment of real estate taxes and insurance premiums as otherwise required herein. Line shall have the right to draw upon the reserve (or pledge) account to pay such items, and Lender shall not be required to determine the validity or accuracy of any item before paying it. Nothing herein or in any of the Relead rocuments shall be construed as requiring Lender to advance other monies for such purposes, and Lender shall not incur any liability for anything it may do or omit to do with respect to the reserve account. LENDER'S EXPENDITURES. If any action of proceeding is commenced that would materially affect Lender's interest in the Property or if Grantor fails of one ply with any provision of this Mortgage or any Related Documents, including but not limited to Grantor's raillure to comply with any obligation to maintain Existing Indebtedness in good standing as required below, or to discharge or pay when due any amounts Grantor is required to discharge or pay under this Mortgage or any Related Documents, Lender on Grantor's behalf may (but shall not be obligated to) take any action that Lender belows appropriate, including but not limited to discharging or paying all taxes, liens, security interests, ender help and other claims, at any time levied or placed on the Property and paying all costs for insuring, maintaining and preserving the Property. All such expenditures incurred or paid by Lender for such purposes will than bear interest at the rate charged under the Note from the date incurred or paid by Lender to the date of repayment by Grantor.
