- B. Pursuant to Section 4.8(b) of the Declaration and Section 31 of the Act, and as the sole owner of Unit 1002, D&B desires to amend the Declaration as follows:
 - 1. THE SUBDIVISION OF UNIT 1002. Pursuant to Section 4.8(b) of the Declaration and Section 31 of the Act, D&B as sole owner of Unit 1002, desires to amend the Declaration to reflect the subdivision of Unit 1002 into two new units. This change does not affect any other Units, any of the common elements, or any of the limited common elements. This Amendment was submitted to and duly authorized by the vote of at least 2/3 of the members of the Board of Director of the Association.
