- (a) ASSUMPTION FUNDING FEE. A we equal to one-half of one percent (0.5 %) of the balance of this loan as of the date of natural fer of the property shall be payable at the time of transfer to the loan holder or its authorized agent, as trustee for the Department of Veterans Affairs. The assumer further agrees to indemnify the Department of Veterans Alairs to the extent of any claim payment arising from the guaranty or insurance of the indebtedness created by this instrument.
