annually beginning on JUNE 1, 2018 to reflect changes in the interest rate in effect from time to time, and
which payments are to be applied, first, to interest, and the balance to principal, until said indebtedness is paid in full.
(2) The interest rate the Mortgagor will pay may change on the **FIRST** ( ***1 <sup>ST</sup> *** ) day of JUNE , 20 18, and on that day of the month every ***TWELVE*** ( ***12*** ) months thereafter. Each date on which the interest rate could change is called a "C¹ anye Date". Beginning with the first Change Date, the interest rate will be based on an "Index". The Index is the weekly average yield change States Treasury Securities adjusted to a constant maturity of ***ONE*** ( ***1*** ) year, as made available by the Jeogral Reserve Board. The most recent Index figure available as of 45 days before each Change Date is called the "Current Index". If the Index is no longer available, the Mortgagee will choose a new Index which is based upon comparable information. The Mortgagee will give the Mortgagor notice of its choice.
(3) Before each Change Date, the Mortgagee will calculate the new interest rate by adding **THREE AND ONE-QUARTER**  percentage points (****3.25%*****) to the Current Index. The sum will be the new interest rate. Notwithstanding the foregoing, the minimum interest rate charged upon the Note on each Change Date will be *****FOUR AND ONE-QUARTER***** percent (*****4.25%*****) per annum. The Mortgage will then determine the amount of the monthly payment that would be sufficient to repay in full the principal the Mortgagor is expected to owe on the Change Date in substantially equal payments based upon the remaining amortization period of the loan at the new interest rate. The result of this calculation will be the new amount of the monthly payment. The new interest rate will become effective on each Change Date. The Mortgagor will pay the amount of the new monthly payment beginning on each Change Date until the amount of the roothly payment changes again.

D (1) That in case of failure to perform any of the covenants herein, Mortgagee may do on Mortgagor's behalf everything so covenanted; (2) that said Mortgagee may also do any act it may deem necessary to protect the lien hereof; that Mortgagor will repay upon demand any moneys paid or disbursed by Mortgagee for any of the above purposes and such moneys together with interest thereon at the highest rate for which it is then lawful to contract shall become so much additional indebtedness secured by this mortgage with the same priority as the original indebtedness and may be included in any decree foreclosing this mortgage and be paid out of the rents or proceeds of sale of said premises if not otherwise paid; (3) that it shall not be obligatory upon the Mortgagee to inquire into the validity of any lien, encumbrance or claim in advancing moneys as above authorized, but nothing herein contained shall be construed as requiring the Mortgagee to advance any moneys for any purpose nor to do any act hereunder; (4) that unless Mortgagor provides Mortgagee with evidence of the insurance coverage required by this agreement with Mortgagee, Mortgagee may purchase insurance at Mortgagor's expense to protect Mortgagee's interest in the property.
