

0000000 This Mortgage made this March 29, 2012, between Chicago Title Land Trust Company, as Trustee under trust 8002359107 (hereinafter referred to as the "Mortgagor") and GreenChoice Bank, fsb (hereinafter refer) ed to as "Mortgagee").

WITNESSETH:

WHEREAS:

Mortgagor is justly indebted to Mortgagee in the principal sum of Nine Hundred Nineteen Thousand and 00/100 (\$919,000.00) Dollars as evidenced by a certain Promissory Note of even date herewith executed by Mortgagor, made payable to the order of and delivered to Mortgagee (hereinafter referred to as the "Note") whereby Mortgagor promises to pay the said principal sum or so much thereof as may be advanced by the holder of the Note from time to time, together with interest thereon, from date, at the rate set forth derein, in installments as set forth therein at the office of Mortgagee, or at such other place as may be designated in writing by the legal holders thereof until the entire principal and accrued interest has been paid pursuant to the terms of the said Note. As used herein the term Note shall include any extension, renewal or modification of the Note.

NOW, THEREFORE, in order to secure the payment of the said principal sum and interest thereon and the performance of the covenants and agreements herein contained, Mortgagor does by these presents grant, bargain, sell, remise, release, alienate, convey, and mortgage unto Mortgagee, its successors and assigns forever, the various parcels of real estate and all of its estate, right, title, and interest therein to said parcels situated in the City of Chicago, Town of Cicero and Elk Grove Village, County of Cook, and State of Illinois, as more particularly described in Exhibit "A" attached hereto and made a part hereof (sometimes herein referred to as the "real estate"), which real estate, together with the following described property, is collectively referred to as the "premises;"

#### TOGETHER WITH:

- (1) All right, title, and interest of Mortgagor, including any after-acquired title or reversion, in and to the beds of the ways, streets, avenues, vaults, and alleys adjoining the premises;
- (2) All and singular right, title, and interest of Mortgagor to the tenements, hereditaments, easements (including, but not limited to, the easements for ingress and egress and for parking, described in Exhibit A hereto), minerals, appurtenances, passages, waters, water courses up rian irrigation, and drainage rights, and other rights, liberties, and privileges thereof or in any way now or hereafter appertaining, including homestead and any other claim at law or in equity as well as any after-acquired title, franchise, or license and the reversion and reversions and remainder and remainder thereof;
- (3) All right, title, and interest of Mortgagor to the rents, issues, proceeds, and profits accruing and to accrue from the premises (which are pledged primarily and on a parity with the real estate, and not secondarily);

permitted by law, be deemed to form a part and parcel of the real estate and for the purpose of this Mortgage to be real estate, and covered by this Mortgage, and as to any of the property aforesaid, which does not so form a part and parcel of the real estate or does not constitute a "fixture" (as such term is defined in the Uniform Commercial Code), this Mortgage is hereby deemed to be, as well, a Security Agreement under the Uniform Commercial Code for the purpose of creating hereby a security interest in such property, which Mortgagor hereby grants to the Mortgagee as Secured Party (as such term is defined in the Uniform Commercial Code), it being further understood and agreed that the provisions of this subparagraph (4) shall not apply or attach to any trade fixtures or personal property of any tenant of the premises, or any contractor or any subcontractor;

- All right, title, and interest of Mortgagor to any and all awards or payments, including interest thereon, and the right to receive same, which may be made with respect to the premises as a result of (a) the exercise of the right of eminent domain; (b) the alteration of the grade of any street; or (c) any other injury to or decrease in the value of the premises, to the extent of all amounts which may be secured by this Mortgage and Security Agreement at the date of inc receipt of any such award or payment by Mortgagee, and of reasonable counsel fees, costs, and disbursements incurred by Mortgagee in connection with the collection of such award or payment, and

1. Payment of Principal and Interest. Mortgagor shall pay promptly when due the principal and interest on the indebtedness evidenced by the Note at the times and in the manner herein and in the Note provided.

Tax and Insurance Deposits. The Mortgagor shall deposit with the Mortgagee, or a depository designated by Mortgagee, in addition to the monthly installments of principal and interest due under the terms of the Note, and concurrently therewith, monthly until the principal indebtedness evidence by the Note is paid, the following: a sum equal to 110% of the most recently ascertainable real estate taxes and assessments based upon the most recent information from the taxing authorities ("taxes") and insurance premiums next due on the premises (all as estimated by Mortgagee in its reasonable discretion), divided by twelve and multiplied by the number of months to elapse prior to the date when such taxes or insurance premium will become due and payable. Mortgagor, on the date hereof, shall also deposit an amount base's upon the taxes, on an accrual basis so that a sufficient reserve for taxes shall be on deposit with Mortgagee to pay the then next due tax payment. All such payments described in this Section 2 shall be held by Mortgagee or a depository designated by Mortgagee in trust without accruing or without any obligation arising for the payment of interest thereon. If the funds so deposited are insufficient to pay, when due, all taxes and premiums as aforesaid, the Mortgagor shall, within ten (13) days after receipt of demand therefor from Mortgagee or its agent, deposit such additional funds as may be necessary to pay such taxes and premiums. If the funds so deposited exceed the amount; required to pay such items, the excess shall be applied on the next due deposits. Neither the Mortgagee nor depository shall be liable for any failure to make the payments of insurance premiums, or of taxes, unless Mortgagor, while not in default hereunder, shall have requested said Mortgagee cr depository in writing to make application of such deposits to the payment of the particular insurance premium or taxes, accompanied by the bills for such insurance premiums or taxes, provided, now ver, Mortgagee may at its option make or cause the depository to make any such application of the aforesaid deposits without any direction or request to do same by Mortgagor. Mortgagee may suspend, in whole or in part, and later reinstate, the application of this section as often as it may determine. In the event of a default and after the expiration of any relevant cure period, if any, in any provision contained herein or in the Note secured hereby, Mortgagee may, at its option, apply my monies on deposit pursuant to this Section 2 (except for monies deposited by tenants of the Mortgagor to pay real estate taxes which funds have been deposited with the Mortgagee and which funds must be used for their intended purpose) against any of the Mortgagor's obligations hereunder or in the Note contained, in such order and manner as the Mortgagee may elect. Such deposits are never y pledged as additional security for the indebtedness hereunder and shall be held in trust to be irrevocably applied by the depository for the purposes for which made hereunder and shall not be subject to the direction or control of the Mortgagor; provided, however, that neither the Mortgagee nor said depository shall be liable for any failure to apply to the payment of taxes or insurance any amount so deposited, unless Mortgagor, while not in default hereunder, shall have requested said depository in writing to make application of such funds to the payment of particular taxes or insurance premiums for payment of which they were deposited accompanied by the bills therefor. payments are made when due no tax and insurance deposit shall be necessary. The Mortgagee reserves the right to require such deposits in its sole reasonable discretion.

3. Taxes. Mortgagor shall pay prior to the date when such matters are due and owing, all general taxes, special taxes, special assessments, water charges, sewer service charges, and all other charges of whatever kind, ordinary or extraordinary, which may be levied or imposed against the premises, and to furnish to Mortgagee official receipts therefor within sixty (60) days after payment thereof, provided, however, if Mortgagee has not suspended the monthly deposits for taxes required by Section 2 hereof, Mortgagee, at its option, either may make such deposits available to Mortgagor for the payments required under this Section 3, or may make such payments on behalf of Mortgagor.

#### 4. Insurance

Casualty. Mortgagor shall keep the improvements now existing or hereafter erected on the premises constantly insured against loss or damage under such types and forms of insurance policies and in such amounts and for such periods as Mortgagee may from time to time require, which shall not be less than the full replacement value of the improvements as determined by the Mortgagee in its sole discretion, and Mortgagor shall pay promptly, when due, any premiums on such insurance. Unless Mortgagee otherwise agrees, all such insurance shall provide "all risk" agreed value replacement cost coverage and shall be carried with companies having a Best's rating of A+ or A. acceptable to the Mortgagee and the policies and renewals (or certificates evidencing same), marked by the insurer "PAID" shall be delivered to the Mortgagee at least thirty (30) days before the expiration of the old policies and shall have attached thereto standard noncontributing mortgage clauses in favor of and entitling the Mortgagee alone to collect with notice to the Mortgagor any and all of the proceeds payable under all such insurance, as well as standard waiver of subregation endorsements. Mortgagor shall not carry separate insurance, concurrent in kind or form and contributing in the event of loss, with any insurance required hereunder. In the event of a change in ownership or of occupancy of the premises (if approved in writing by Mortgagee), immediate notice thereof by mail shall be delivered to all insurers. In the event of any material loss covered by such insurance, Mortgagor shall immediately notify Mortgagee in writing, and Mortgagor hereby authorizes and directs each and every insurance company concerned to make pryments for such loss directly to the Mortgagee (who may, but need not, make proof of loss) and said Mortgagee is hereby authorized to adjust, collect and compromise in its discretion with rotice to the Mortgagor all claims under all policies and Mortgagor shall sign, upon demand by said Mortgagee, all receipts, vouchers, and releases required by such insurance companies. After deducting any reasonable costs of collection, Mortgagee shall use or apply its share of the proceeds to repair and restore the improvements in which event the Mortgagee shall not be obligated to see to the proper application thereof nor shall the amount so released or used for restoration be deemed a payment on the indebtedness secured hereby and to apply any excess to reduce the principal balance of the Mortgage. Such proceeds shall be made available, from time to time, upon Mortgagee being furnished with satisfactory evidence of the estimated cost of such restoration and with such architect's certificates, waivers of lien, contractors' sworn statements and other evidence of cost and of payments as Mortgagee may reasonably require and approve. If the estimated cost of the work exceeds ten percent (10%) of the original principal amount of the

indebtedness secured hereby, the Mortgagee shall be supplied with all plans and specifications for such rebuilding or restoration as Mortgagee may reasonably require and approve. No payment made prior to the final completion of the work shall exceed ninety percent (90%) of the value of the work performed by each respective trade, from time to time, and at all times the undisbursed balance of said proceeds remaining in the hands of Mortgagee shall be at least sufficient to pay for the cost of completion of the work, free and clear of any liens. In the event of foreclosure of this Mortgage, or other transfer of title to the premises in extinguishment of the indebtedness secured hereby, all right, title, and interest of Mortgagor, in and to any insurance policies then in force, and any claims or proceeds thereunder shall pass to Mortgagee or any purchase, o grantee. In the event Mortgagee, in its reasonable discretion, determines that any insurance provided by Mortgagor, does not comply with the insurance requirements set forth herein, then Mortgagee may, at any time and at its own reasonable discretion, procure and substitute for any and all of the insurance so held as aforesaid, such other policy or policies of insurance, in such amount and carried in such company as it may reasonably determine, the cost of which shall be repaid to Mortgagee by Mortgagor upon demand. Mortgagor shall furnish to Mortgagee, upon its request estimates or appraisals of insurable value, without cost to the Mortgagee, such as are regularly and ordinarily made by insurance companies to determine the then replacement cost of the building or buildings and improvements on the premises in the event Mortgagee reasonably believes that the replacement value or the real estate has been appreciably altered. In the event are proceeds are applied to reduce the indebtedness, the payments that are to be made pursuant to the Note executed contemporaneously with this Mortgage shall be reduced pro rata and the affect of such prepayment shall reduce the amount of the final (balloon) payment due pursuant to the said Note. Notwithstanding the foregoing, in the event of a loss covered by insurance, the Mortgagor shall be allowed to adjust the loss and to rebuild or repair the premises so long as the Mongagor is not in default pursuant to this Mortgage.

- (b) <u>Liability</u>. Mortgagor shall carry and maintain comprehensive public liability insurance as may be reasonably required from time to time by Mcregagee in forms, amounts, and with companies having a Best's rating of A+ or A or reasonably saus factory to Mortgagee, and Mortgagor will apply all insurance proceeds under such policies to the payment and discharge of the liabilities in respect of which such proceeds are collected. It is understood and agreed that the amounts of coverage shall not be less than Two Million and No/100 Dollars (\$2,000,000.00) single limit and Three Million and No/100 Dollars (\$3,000,000.00) umbrella coverage and that the policy shall name Mortgagee as an additional insured party thereunder. Certificates of such insurance, premiums prepaid, shall be deposited with Mortgagee and shall contain provision for twenty (20) days' notice to Mortgagee prior to any cancellation thereof.
- (c) <u>Flood Insurance</u>. Mortgagor shall carry and maintain in force at all times flood insurance in accordance with the provisions of the Flood Disaster Protection Act of 1973, as amended, if the area in which the premises are situated is designated as "flood prone" or a "flood risk area," as defined in said Act, in an amount satisfactory to Mortgagee, and Mortgagor shall comply with such other requirements of said Act as are appropriate.
- (d). <u>Policies</u>. Unless Mortgagee otherwise agrees, all policies of insurance required hereunder to be maintained by Mortgagor, together with evidence that the premium

therefor covering the current premium year has been prepaid, shall be deposited with Mortgagee and shall provide for, among other things, written notice to Mortgagee of their expiration or any anticipated cancellation at least twenty (20) days prior to such event occurring. Not less than thirty (30) days prior to the expiration of any such policy, Mortgagor shall deposit an appropriate renewal or replacement policy and evidence of the premium payment therefor, as aforesaid.

(e). Collateral Protection Act Notice. Unless the Mortgagor provides the Mortgagee with evidence of the insurance coverage required by this Mortgage, the Mortgagee may purchase insurance at the expense of the Mortgagor to protect the interest of the Mortgagee in the premises. This insurance may, but need not, protect the interest of the Mortgagor in the premises. The coverage that the Mortgagee purchases may not pay any claim that the Mortgagor may make one of claim that is made against the Mortgagor in connection with the premises. The Mortgagor may later cancel any insurance purchased by the Mortgagee, but only after providing the Mortgagee with evidence that the Mortgagor has obtained insurance as required by this Mortgage. If the Mortgagee purchases insurance for the premises, the Mortgagor will be responsible for the costs of that insurance, including interest and any other charges the Mortgagee may impose in connection with the placement of the insurance, until the effective date of the cancellation or expiration of the insurance. The costs of the insurance may be added to the total outstanding balance or poligation of the Mortgagor to the Mortgagee. The costs of the insurance obtained by the Mortgagee may be more than the cost of insurance the Mortgagor may be able to obtain on its own behalt.

#### 5. Requirements Pertaining to Premises.

Preservation, Restoration and Use of Premises. Except in the ordinary (a) course of business of the Mortgagor, no building or other improvement on the premises shall (except as required by law) be altered, removed, or demolished nor shall any fixtures or appliances on, in or about said buildings or improvements be severed, removed, sold or mortgaged, without the prior written consent of Mortgagee, and in the event of the demolition or destruction in whole or in part of any of the fixtures, chattels, or articles of personal property covered hereby or by any separate security agreement given in conjunction herewith, the same shall be replaced promptly by similar fixtures, chattels, and articles of personal property at least equal in quality and condition to those replaced, free from any security interest in or encumbrances thereon or reservation of title thereto. Mortgagor shall promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which nav become damaged or be destroyed. The buildings and improvements shall be so restored or rebuilt so as to be of at least equal value and substantially the same character as prior to such damage or Mortgagor shall not permit, commit, or suffer any waste, impairment, or deterioration of the premises or any part or improvement thereof, and shall keep and maintain the premises and every part thereof in good repair and condition and to effect such repairs as Mortgagee may reasonably require, and, from time to time, to make all needful and proper replacements and additions thereto so that said buildings, fixtures, machinery, and appurtenances will, at all times, be in good condition, fit and proper for the respective purposes for which they were originally erected or installed. To the extent an elevator are part of the premises, the Mortgagor agrees that it shall obtain an elevator maintenance agreement reasonably acceptable to Mortgagee until the Note secured hereby has been paid in full in the event an elevator is installed
