WHEREAS, PAN AMERICAN BANK is willing to subordinate its mortgage on real estate to the mortgage to be made to FIRST NATIONS BANK.

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is agreed by the parties as follows:

SECTION 1. PAN AMERICAN BANK hereby subordinates its mortgage on the above described real estate to the mortgage to be made by Grantor, to secure its loan from FIRST NATIONS BANK in the principal sum of FIFTY THOUSAND Dollars and no/100 (\$50,000.05) Dollars and all additional amounts which the Grantor may be obligated to pay pursuant to the terms of the note or mortgage.

SECTION 2. PAN AMERICAN BANK agrees that the mortgage to FIRST NATIONS BANK on said real estate shall be a Second lien on the real estate to that of PAN AMERICAN BANK'S 1ST MORTGAGE DATED JULY 15, 2011, recorded August 8, 2011 as document number 1122004050, and that FIRST NATIONS BANK'S MORTGAGE, shall have absolute priority over PAN AMERICAN BANK'S JUNIOR MORTGAGE DATED September 13, 2012, recorded September 25, 2012 as document number 1226948005.

In order to carry out the terms of this agreement, the Grantor shall do all acts necessary and convenient to preserve for the FIRST NATIONS BANK the benefit of this Subordination Agreement, by executing such other documents, financing statements, or otherwise as the FIRST NATIONS BANK may from time to time request in order to carry out the terms of this Subordination Agreement.

SECTION 4. This agreement shall be binding upon and insure to the benefit of the parties, their heirs, successors, administrators and assigns.
