



2. Application of Payments or Proceeds. Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. "Environmental Condition" means a condition that can cause, contribute to, or otherwise trigger an Environmental Cleanup.

If at some point in the future this Index is no longer available, the Lender will use an alternative Index that is base I on information the Lender believes to be comparable. The interest rate you will pay until the first Rate Change Date is called the Initial Interest Rate.

B. How Your Interest Rate Can Change
