Any notice to Borrower provided for in this Security Instrument snell be given by delivering it or by mailing it by first class mail unless applicable law requires use of another method. 16. Hazardous Substances. Borrower shall not cause or permit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property. Borrower shall not do, nor allow anyone else to do, anything affecting the Property that is in violation of any Environmental Law.
