## NOTICE OF LIEN FOR UNPAID COMMON CHARGES

Please take notice that the Phorndale Beach North Condominium Association, an Illinois not-for-profit corporation, the undersigned Lienor, has and claims a lien for unpaid common elements charges pursuant to 765 Illinois Compiled Statutes 605/9, and pursuant to Article VI, Section 7 of the Declaration of the Association, as follows:
